



Annual Report 2022



JHPC wants to thank everyone who helped make 2022 an extraordinary year including those who donated in the past five months.

Important highlights include:

- 2.5 million dollars were raised from over 700 donations and 600 donors including a 1 million dollar RACP grant from the State of Pennsylvania and a 1 million dollar gift from a private donor
- Greater local media coverage helped spread community awareness and understanding of JHPC's mission and the increasing need for a facility to help those who are at the end of their lives or living with a serious illness
- JHPC now has over 3.5 million dollars in assets for our Julia House project in McKean
- The Julia Palliative Care office practice in Millcreek grew by over 600%

Thanks to the support of our community, we have made tremendous strides towards starting the construction of phase 1 of Julia House, Erie's first inpatient hospice facility and palliative medicine clinic. With your continued support, we can raise the necessary funds and break ground this fall.





Thanks to State Representative Ryan Bizzaro and Senator Daniel Laughlin, Julia Hospice and Palliative Care was approved to receive a 1 million dollar grant from the state of Pennsylvania to fund the construction of Julia House. This was done in an effort to improve healthcare options for people living with serious illnesses throughout the region. Funding for these projects is supported through the Redevelopment Assistance Capital Program. Rep Ryan Bizzaro stated that "I was understandably moved by their vision – as anyone would be, especially those who have needed to secure hospice care for a loved one – and I'm thrilled that they have been awarded a \$1 million state grant that will allow this project to move forward."
